WAS AN ORGANIZER TO ENCOURAGE BLACK PEOPLE TO REGISTER TO VOTE WHEN HE SPENT LONG VACATIONS IN HIS HOME COMMUNITY. ESPECIALLY WORKED WITH YOUTH AND HELD CITIZENSHIP CLASSES. TRULY BELIEVED AS WAS INSTILLED IN THE MADISON FAMILY BY THE PATRIARCH ELI MADISON THAT THE FAMILY WAS A PART OF DUBOIS' "TALENTED TENTH" TO SERVE THE RACE. ALL OF THE MADISONS EXCELED AS LAWYERS, DOCTORS, EDUCATORS, SCIENTISTS (FIVE GENERATIONS ARE REPRESENTED IN THESE FIELDS WITH DISTINCTION, SEVERAL FAMILY MEMBERS HAVE BEEN ASSESSED BY WHITE STANDARDS AND INSTRUMENTS AS GENIUSES).

MARRIAGE: TO THE LATE MARY LOVELESS, SISTER TO THE UNDERTAKER PROPRIETOR, JOHN HENRY LOVELESS. HIS FUNERAL HOME WAS SOLD TO ROSS AND CLAYTON (RU-FUS LEWIS' WIFE). MARY PRECEDED MADISON IN DEATH.

> ONE DAUGHTER----JOSEPHINE "SUNSHINE" (NICKNAME GIVEN BY FATHER DIVINE) MADISON BURTON. HER MARRIAGE PRODUCED ONE SON, WHO WAS THE "DARLING" OF ARTHUR MADISON, GRANDFATHER.

TYPES OF CASES: VOTING RIGHTS, CIVIL AND CRIMINAL PRACTICES, TRIED MANY CASES AND AND SUCEEDED WITH "INNOCENT BY REASON OF INSANITY." CLIENTS WOULD BE COM-MITTED AT HARLEM VALLEY HOSPITAL IN WINGDALE, NY. WHEN CLIENTS WERE RE-LEASED AS OUTPATIENTS, SEVERAL STAYED WITH MADISON IN THE BASMENT APART-MENTS IN HIS BROWNSTONE HOME IN HARLEM.

> LAWYER AND FINANCIAL MANAGE FOR FATHER DIVINE, WHO WAS PROHIBITED TO BE IN NYC AFTER 12:00 MIDNIGHT ON SUNDAYS. HELPED FATHER DIVINE RE-ESTABLISH HIS HEADQUARTERS IN PHILADELPHIA, PA.

- SOCIAL LIFE AND FRIENDS: SOUGHT AFTER AS AN ESCORT FOR HIGH SOCIETY LADIES. FRIENDS TO ADAM CLAYTON POWELL, SR AND PAUL ROBESON.
- 7 POLTICIS: RAN SEVERAL TIMES FOR CITY COUNCIL IN NEW YORK CITY (HARLEM), TRIED VOTING RIGHTS CASE IN MONTGOMERY IN THE 1940S AND WAS DISBARRED FOR DOING SO IN ALABAMA IN 1944.
 - CHURCH: MOTHER ZION AMEZ IN HARLEM. PAUL ROBESON'S BROTHER WAS THE MINISTER .
 - DEATH: BECAME BLIND DUE TO GLAUCOMA. HIS GRANDSON WAS HIS CLOSE COMPANION AND GUIDE. FELL DOWN A FLIGHT OF STAIRS THAT RESULTED IN HIS DEATH IN NEW YORK CITY IN 1957. BODY SHIPPED HOME FOR BURIAL IN MADISON PARK.
