The Board of Directors Authorized Manager Strawn to make application to amend the Charter to bring the Industrial School Faculty into the scope of Membership. The National Credit Union Administration approved the Charter Amendment and the Alabama Industrial School Faculty became eligible to become members of the Montgomery Teachers Federal Credit Union.

The successful entry of the Industrial School into the field of Membership ~~prompted~~ inspired the ^{Faculty + Staff} Trenholm State Technical College to request entry into the Montgomery Teachers Federal Credit Union's field of Membership. The Credit Union again was successful in having its Charter Amended to accept the Trenholm State Technical College Faculty and Staff into its scope of Membership. This entry of Trenholm Tech brought with it Payroll deduction which proved to be a tremendous boost to the assets of the Credit Union. With the entry of

the Industrial School and Greerholm Technical College, the Montgomery Teachers Federal Credit Union experienced rapid growth in both membership and assets. Much of this growth is attributed to Jean Walton who in her spare time went from school to school encouraging teachers to become members of their Credit Union. Each pay period found Jean Walton serving as cashier for those teachers who wished to send their obligations to the Credit Union Manager.

For thirteen years Edward Stuenkel served as Treasurer - Manager of the Montgomery Teachers Federal Credit Union. The Manager of Maywell - Hunter Credit Union provided valuable assistance to the MTFCU during its formative years. He and Stuenkel would spend many hours into midnight at ^{the} Maywell office ~~and studying~~ ^{studying} Credit Union regulations and procedures. These long midnight hours paid-off for the Annual Federal Audits were always above a reprimand. The Credit Union was never cited in any audit under Edward Stuenkel's management. A BRIEF HISTORY OF THE FOUNDERING OF
THE MONTGOMERY TEACHERS FEDERAL CREDIT UNION;
A FINANCIAL INSTITUTION ORIGINALLY ESTABLISHED
BY BLACK EDUCATORS WHO WERE CONCERNED OVER
THE PLIGHT AND DIFFICULTY THAT BLACK TEACHERS
EXPERIENCED TRYING TO OBTAIN LOANS FROM
BANKS AND OTHER LENDING INSTITUTIONS IN
MONTGOMERY, ALABAMA. THIS BRIEF HISTORY BY
NO MEANS GIVES CREDIT TO ALL OF THOSE BLACK
EDUCATORS IN MONTGOMERY WHO GAVE OF THEIR
TIME, MONEY AND EFFORT TO SEE THAT THEIR
CREDIT UNION MOVEMENT SUCCEEDED.

IN EARLY 1961 FIVE EDUCATORS, PRINCIPAL C.T. SMILEY, PRINCIPAL CLINTON ELMORE, TEACHER FANNIE C. JONES, SUPERVISOR MAGGIE Y. FORTE AND PRINCIPAL EDWARD STEVENS MET AT McDAVID ELEMENTARY SCHOOL IN PRINCIPAL EDWARD STEVENS OFFICE TO DISCUSS THE PLIGHT OF A ^{BLACK} TEACHERS AND THE PROBLEMS THEY ENCOUNTER TRYING TO OBTAIN LOANS FROM BANKS.

THIS MEETING RESULTED IN AN AGREEMENT TO SEEK THE ADVICE AND TECHNICAL ASSISTANCE OF THE ALABAMA CREDIT UNION LEAGUE. THE LEAGUE ASSIGNED GARY WOLTERS AND THOMAS LIGHT TO ASSIST AND RENDER THE TECHNICAL ASSISTANCE NECESSARY TO ESTABLISH A CREDIT UNION.

SUBSEQUENT MEETINGS WITH GARY WOLTER, THOMAS LIGHT AND THE MANAGER OF THE MAXWELL - GUNTER CREDIT UNION RESULTED IN C.T. SMILEY, CLINTON ELMORE, FANNIE C. JONES, MAGGIE Y. FORTE AND EDWARD STEVENS SUBMITTING THE NECESSARY FUNDS TO APPLY FOR A FEDERAL CHARTER TO ESTABLISH A CREDIT UNION FOR TEACHERS IN MONTGOMERY COUNTY, ALABAMA. IN MAKING APPLICATION THESE CREDIT UNION FOUNDERS HAD TO DECIDE ON A FIRM NAME AND A ~~FIELD~~ ^{FIELD} OF MEMBERSHIP. IN ORDER TO BRING ALL OF THE TEACHERS IN MONTGOMERY INTO THE SCOPE OF MEMBERSHIP, MR. STEVENS SUGGESTED THAT THE

APPLICATION BE SUBMITTED UNDER THE NAME OF "THE MONTGOMERY TEACHERS FEDERAL CREDIT UNION." THE SCOPE OF MEMBERSHIP WOULD THEN EMBRACE ANYONE ^{OF ANY ETHNIC ORIGIN} WHO WORKS FOR THE MONTGOMERY COUNTY BOARD OF EDUCATION, MEMBERS OF THEIR IMMEDIATE FAMILY AND ORGANIZATIONS OF SUCH PERSONS, BY DOING SO WOULD NOT LIMIT MEMBERSHIP TO "NEGRO" OR MINORITY EMPLOYEES. THIS APPLICATION FOR A CHARTER WAS SUBMITTED TO THE NATIONAL CREDIT UNION ADMINISTRATION. THE ADMINISTRATION APPROVED THE APPLICATION AND THE CHARTER GRANTED IN MAY OF 1961. THE MONTGOMERY TEACHERS FEDERAL CREDIT UNION WAS NOW BORN AND READY TO OPERATE WITH ALL ACCOUNTS INSURED BY THE CUNA MUTUAL INSURANCE SOCIETY. THE TEACHERS ^{AND SCHOOL PERSONNEL} NOW OWNED THEIR OWN INSTITUTION FOR SAVINGS AND LOAN. IT WAS NOW UP TO THE ORIGINAL FOUNDERS TO CONVINCE THE FAMILY OF EDUCATORS IN MONTGOMERY THAT THEIR CREDIT UNION WAS A VIABLE INSTITUTION AND THEY WERE THE OWNERS.

AS PART OF THE REQUIREMENTS OF THE CHARTER THE CREDIT UNION HAD TO ESTABLISH A SUPERVISORY COMMITTEE AND A LOAN COMMITTEE ALONG WITH THE BOARD OF DIRECTORS. THE ORIGINAL BOARD OF DIRECTORS WERE: C.T. SMILEY, CHAIRMAN, MAGGIE Y. FORTE, VICE CHAIRMAN,

FANNIE C. JONES, SECRETARY. EDWARD STEVENS WAS CHOSEN AS THE CREDIT UNION MANAGER, A POSITION HE HELD FOR THIRTEEN YEARS UNTIL BEING HIRED BY THE ALABAMA STATE DEPARTMENT OF EDUCATION. HE STEERED THE CREDIT UNION THROUGHOUT ITS FOUNDERING YEARS.

CLINTON ELMORE AND GEORGE THOMPSON, PRINCIPAL OF CARVER HIGH SCHOOL GUIDED THE SUPERVISORY COMMITTEE THROUGH SOME OF THE MOST COMPLIMENTARY FEDERAL AUDITS OF THE CREDIT UNION. HERMAN HARRIS, PRINCIPAL OF CARVER JR. HIGH SCHOOL WORKED DILIGENTLY IN SEEING THAT HIS TEACHERS WERE INFORMED OF ALL ASPECTS OF THEIR CREDIT UNION.

THE MONTGOMERY TEACHERS FEDERAL CREDIT UNION OWES A DEEP DEBT OF GRATITUDE TO LEAN WALTON AND PRESTON MARSHALL. THEY SERVED AS CARRIERS, AMBASSADORS AND VOLUNTEERS FOR THEY WERE DETERMINED ~~THAT~~ TO SEE THAT THE CREDIT UNION WAS A SUCCESS.

THE CREDIT UNION PETITIONED THE SUPERINTENDENT AND BOARD OF EDUCATION MANY TIMES TO GRANT PAYROLL DEDUCTION TO ITS MEMBERS. EACH TIME THE BOARD AND SUPERINTENDENT REFUSED. OF COURSE AT THIS TIME THE CREDIT UNION WAS STILL FULLY STAFFED AND CONTROLLED BY THE BLACK

EDUCATORS AND THE SCHOOL SYSTEM WAS COMPLETELY
SEGREGATED. THIS PROBABLY ACCOUNTED FOR
THE FACT THAT PAYROLL DEDUCTION WAS
DENIED.
