## A BILL

To provide for the establishment of a Federal Voter Registration Commission to provide, in certain instances, for the registration of citizens of the United States for the purpose of voting in Federal and State elections, and for other purposes.

## Major Provisions:

- 1. Creation of a Federal Voter Registration Commission of five members appointed by the President by and with the advice and consent of the Senate.
- 2. Commission empowered to:
  - A. Register citizens to vote for candidates for the U. S. Congress where it finds that local registration machinery has been inoperative for 60 days or more.

State qualifications would apply with the exception of literacy tests and payment of poll tax. Authority: Article I, Sec. 4, U. S. Constitution.

B. Register voters and administer elections where it finds that the right to vote has been denied or abridged on account of race or color by any State, or any officer of employee of any State or any political subdivision of a State.

This would apply to Federal, State and local elections. Such action to remain in effect for not less than five years and would be discontinued only upon request by a majority of registered voters.

Authority: 15th Amendment, U. S. Constitution.

3. Commission action reviewable by the Federal Courts where the appeal is to be given preference over other cases. No appeal, however, would cause delay of any finding or action taken by the Commission.
