WITNESSETH, that for and in consideration of the sum of Ten Dollars the said party hereto of the first part, does grant unto the said parties hereto of the second part, in fee simple, as Tenants by the Entirety,

the following described land and premises, with the improvements, easements and appurtenances thereunto belonging, situate in the District of Columbia, namely:---

No part of the land hereby conveyed shall ever be used, or occupied by, or sold, demised, transferred, conveyed unto, or in trust for, leased, or rented, or given, to negroes, or any person or persons of negro blood or extraction, or to any person of the Semitic Race, blood, or origin, which racial description shall be deemed to include Armenians, Jews, Hebrews, Persians and Syrians, except that; this paragraph shall not be held to exclude partial occupancy of the premises by domestic servants of the said parties hereto of the second part, their heirs or assigns.
