LEASE OF SAFE DEPOSIT BOX

LEWIS, RUFUS A.

as Lessee, hereby leases from The First National Bank of Montgomery, a national banking association, of Montgomery, Alabama, as Lessor, safe deposit box number 209 in the vaults of Lessor at Montgomery, Alabama, upon the following terms, agreements and conditions:

1. The relation of Lessor and Lessee under this agreement is that of landlord and tenant, respectively, and under no circumstances, except after the removal of the contents of the box as provided in paragraph 9 hereof, shall Lessor be considered as bailee, or otherwise in control or possession of the contents of the box. Since Lessor has no control or possession of the contents of the box, the liability of Lessor hereunder is expressly limited to the exercise of ordinary care and diligence to prevent the opening of the box by any unauthorized person. Evidence tending to prove that the property was left in the box upon one entry, and that such property, or some part thereof, was missing upon a subsequent entry, or proof of partial or total loss of the contents, shall not be sufficient to raise or create a presumption that the loss was caused by the negligence or wrongdoing of Lessor, nor shall such evidence place upon Lessor the burden of proving that the loss was not the fault of Lessor.

2. No person other than Lessee, his duly appointed deputy or attorney in fact, or the legal representative of Lessee in the event of his death, insolvency, or incompetency, shall have access to the safe deposit box, except as hereinafter otherwise expressly provided. A deputy or attorney in fact may be appointed only in writing and on forms approved by and executed to the satisfaction of Lessor, or by power of attorney signed by Lessee in the presence of two witnesses and acknowledged before an officer authorized to take acknowledgments of deeds under the laws of Alabama. Where the box is rented by two or more persons, all Lessees must join in the appointment of a deputy or attorney in fact. Lessor may consider and treat the appointment of a deputy or attorney in fact to be valid and continuing until notified in writing of its revocation, or until Lessor has actual notice of the death of Lessee. The appointment of a deputy or attorney in fact by two or more Lessees may be revoked by written instrument executed and delivered to Lessor by any one of the Lessees, but shall not be considered as revoked by the death of any one Lessee. Where Lessee is a corporation, no officer, agent or employee of the corporation shall be permitted to have access to the box unless he presents a certified copy of a resolution of the Board of Directors of the corporation authorizing such entry, together with his original signature certified as to its authenticity by the President, Vice President, Secretary, or similar officer of the corporation, and under its seal. The revocation of authority to enter a box rented by a corporation must be by certified copy of a resolution of the Board of Directors of the corporation delivered to Lessor. Lessor shall not be liable for an unauthorized entry into the box, if it conforms to the foregoing requirements in good faith. If Lessor has a reasonable doubt as to the authority of any person to have access to the box, it may refuse access until it has a reasonable opportunity to determine the authority of such person.

3. Where the box is rented by two or more persons, unless they specifically contract in writing that all must enter the box together, each one of them shall have equal access thereto, and any one of them may surrender the box and remove the entire contents thereof, and Lessor shall be under no liability for the unauthorized removal by one Lessee of property belonging to another Lessee. After the death or disability of one Lessee, the surviving or other Lessee shall continue to have access to the box, and Lessor shall be under no liability for the unauthorized removal of any property of the deceased or disabled Lessee by the surviving or other Lessee, nor shall Lessor be under any liability for the unauthorized removal of any property of the deceased or disabled Lessee by the personal representative of the deceased or disabled Lessee. In the event of any controversy or dispute between the Lessees of the box, including husband and wife, or between one Lessee and the personal representative of another Lessee, as to the right of any one or more of them to have access to the box, Lessor may interpose all of the Lessees of said box, or the personal representative of any one or more of them, and pending the determination of such proceeding, refuse access to the box to all of the Lessees and their personal representatives. All of Lessor's costs and expenses in such proceeding, including attorney's fees, shall be paid by Lessees, or their personal representatives, in such proportions as the Court may determine.

4. If by any writ, order, decree or other process issued from any Court against any person entitled to access to the box under the provisions of this lease, Lessor is forbidden to allow the box to be opened by such person, the box may be closed to everyone until such writ, order, decree or process is modified or set aside. The box may be opened upon any order or warrant of Court directed to Lessor requiring the same to be opened, without notice to Lessee or Lessees or any of them, and the contents of the box may be disposed of in accordance with such warrant or order of court, and Lessor shall not be liable to Lessee or Lessees or any of them, or to any other person, for any loss or damage occasioned thereby. Lessor may at any time permit or grant access to the box to any person authorized by the Probate Court of Montgomery County, Alabama, or to a member of the family, or to one in possession of the key, to enter the box to search for the will of a deceased Lessee. Upon any such entry into the box of a deceased Lessee for the purpose of searching for a will, such entry and examination shall be witnessed by an officer of Lessor and at such time nothing shall be removed from the box except a purported will. Lessor shall not be liable for any action taken hereunder in accordance with the writ, order, decree or process of any Court, regardless of whether such writ, order, decree or process is subsequently held to be erroneous or void.

5. Lessee hereby agrees to reimburse Lessor for all costs and expenses whatsoever, including attorneys' fees, incurred by reason of any litigation relative to the box or its contents regardless of whether or not Lessor is made a party to such litigation. All such cost and expenses shall be payable to Lessor upon demand, and upon failure of Lessee to pay the same promptly, Lessor shall have the same rights as though the amount of said costs and expenses were amounts of rent then past due.

6. This lease shall run for one year from the date hereof, and it shall be deemed to be renewed at the same rental and subject to all of the terms, conditions and agreements hereof, for one year from the expiration of the term first above specified, and thereafter from year to year unless at least 10 days prior to the expiration of the term of this lease, or any renewal thereof, Lessee gives to Lessor written notice of the termination of this lease, in which event Lessee must surrender the box and the keys thereto before the expiration of said 10 day period. Lessee hereby acknowledges receipt of 2 keys to the box. Lessee hereby agrees to notify Lessor promptly if a key is lost, and to pay Lessor all expenses incurred by Lessor on account of the loss of such key; and Lessor shall not be liable for any loss or damage caused by the loss of such key.

7. Lessor reserves the right to terminate this lease at any time, and for any reason, upon written notice mailed or delivered to Lessee, or in his absence, to his deputy or other personal representative of Lessee. In such case, upon surrender of the keys to the box and the removal of its contents a due proportion of the rental received will be refunded.

8. All rents are payable yearly in advance. Should the rent remain unpaid at the end of 15 days after the commencement of any term, Lessor shall have the right to exercise its option under paragraph 7 of this lease agreement and terminate the lease; or, in the event that Lessee has funds on deposit with Lessor, to withdraw without further notice to Lessee the amount due for said rent from such deposit account.

9. In the event of the termination of the lease under paragraphs 7 or 8 hereof, Lessor shall, at the end of 15 days after mailing notice of its intended action to the address of Lessee or Lessees as registered on its books, or after direct service of such notice, and if Lessee within said 15 day period fails to surrender the box and return the keys thereto, have the right forcibly to open the safe of such Lessee or Lessees in the presence of two officers of Lessor and one other witness, and to remove the contents therefrom, and to hold and retain the same under the liability of an ordinary storage warehouseman only. Lessor shall have a lien against the contents of the box for the payment of all overdue or unpaid rent, and for all expenses incurred in opening the safe and changing its locks and keys, and also for the safe keeping of the contents after their removal from the safe. In the event these charges are not promptly paid, and the contents remain unclaimed for a period of 6 months after the opening of the safe, Lessor may sell, transfer, assign and deliver the whole or any part of said contents, either at public or private sale, at Lessor's option, at any time or times with or without advertising said sale, or demand upon or notice to Lessee, all of which are hereby waived by Lessee and Lessees, if there be more than one, and Lessor, or its officers, agents or employees, may become the purchaser thereof at such sale or sales the same as if they were strangers; and after deducting all charges and costs of such sale and delivery, the residue of the proceeds of such sale or sales shall be applied to the payment of the charges above mentioned, and the balance, if any, shall be paid to Lessee upon demand. For the purposes of this paragraph, all contents of the safe shall be construed as being the sole property of Lessee, or Lessees, if there be more than one.

10. The box may not be opened or its contents examined within the vault, but only in one of the booths or rooms provided by Lessor for that purpose. Lessor shall not be responsible for any property left in any booth or room, but shall be entitled to the possession of any property found therein, the ownership of which cannot definitely be established, until the true owner is found. Access to the box may be had only during regular banking hours on days when Lessor is open for the transaction of banking business. Lessor may close the vault in which the box is kept at any time in case of fire, riot, mobs, unusual crowds or other emergency, or for any other reason when Lessor shall deem such closing to be prudent or necessary. Lessor shall not be responsible for any delay caused by failure of its vault doors or locks to operate, nor shall Lessor be liable for any loss occasioned by fire, theft, burglary, robbery, or act of God. Lessee may not use the box for storing money, narcotics, or explosives, or for any unlawful purpose.

11. The signature of Lessee to this lease constitutes his conclusive consent to the terms thereof. The terms of this lease shall be binding upon each Lessee herein named, whether one or more individuals, or a partnership, or a corporation, and upon the heirs, personal representatives or successors of each and every Lessee; but this lease may not be assigned.

12. The address of Lessee given on this lease shall be conclusively presumed to be his address for the mailing or giving of any notice hereunder until Lessor receives written notice of a change in address.

13. If any question arises with reference to the box or its contents which is not covered by the provisions of this lease, or if any question arises with reference to the construction of this lease, or its application to any situation which may arise, Lessor reserves the right to defer its action or decision thereon until it has had reasonable time to obtain legal advice, and Lessor shall not be liable for any reasonable delay thereby incurred.

14. Lessor reserves the right to make any further rules and regulations which it may deem necessary for the protection of the box and vault in which it is contained and for the preservation of orderly procedure therein, and such further rules and regulations shall become effective upon posting notice thereof in Lessor's vault or place of business for 5 consecutive business days.

If you mark "X" it must be done in the presence of a witness who will complete the form as shown in the example below and sign it. If the outside envelope is not so marked and signed, your ballot **WILL NOT BE COUNTED AS A VOTE**. Mail your ballot right away; **NO POSTAGE IS NEEDED**.

COUNTING THE VOTES

When your ballot, like all the rest, gets back to your ASCS county office, it will be placed in the ballot box.

Within five days after the election, the votes will be counted publicly by your ASC county committee in a place open to all races. You may watch the counting if you wish.

Before the counting begins, the outside envelopes will be opened and the inside plain envelopes with the ballots will be taken out and placed in a separate pile from the outside envelopes which will be shuffled so that all ballots will be kept secret. Then the plain envelopes will be opened and the votes counted.

Results of the election will be announced in the local newspapers, over radio, and TV where available.

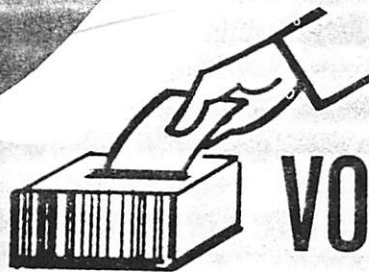
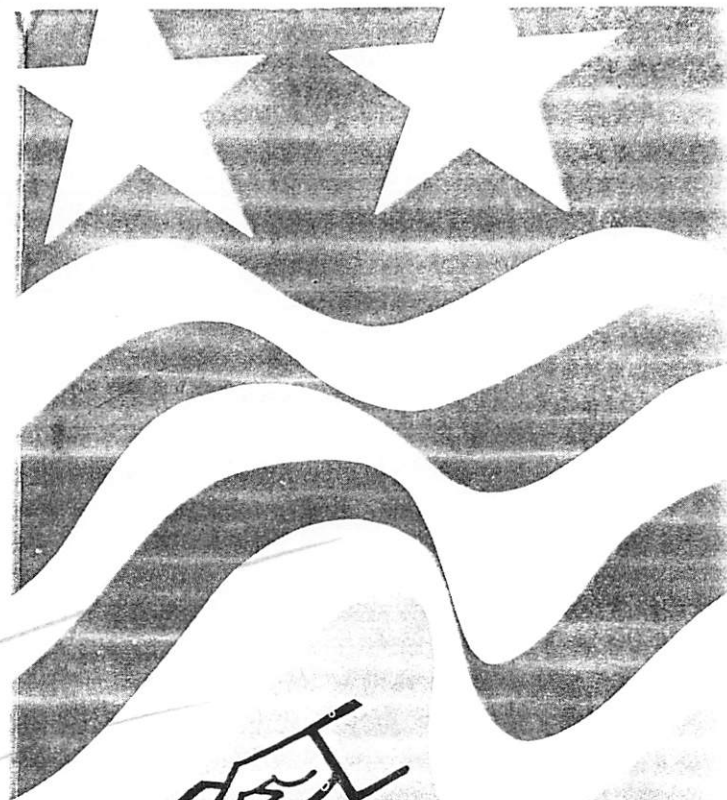
