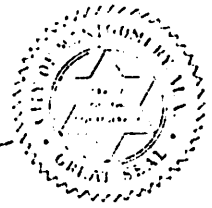

Dear Commissioners:

The Parks and Recreation Department recommends that the City of Montgomery terminate its contract with Ray Wilson, doing business as Wilson's Sporting Goods Company. Mr. Wilson has not performed his contract as agreed upon, in that he is long overdue in delivering adequate equipment and supplies to our Department in time for our Spring program. Although he has been requested several times to make immediate delivery, he has still not done so. The small amount of equipment he has delivered is, for the most part, sub-standard and below specifications.

We strongly urge that the City of Montgomery take immediate steps to terminate the contract, return the sub-standard equipment already delivered, and enter a new contract with a sporting goods company which can deliver the necessary equipment to serve the needs of our Department.
