We, the undersigned, duly qualified electors of the City of Montgomery, Alabama, and residing at the places set opposite our respective names, acting pursuant to the provisions of Section 13 of an Act of the Legislature of Alabama, No. 813, approved September 11, 1951, entitled:

"An Act to provide for and prescribe the form of government for all cities of Alabama having a population of not less than 75,000 nor more than 125,000 inhabitants according to the preliminary count of the 1950 census or any subsequent regular decennial federal census."

do hereby protest against the passage of Ordinance No. 25-57 entitled:

"An Ordinance levying a privilege or a license tax against persons, firms, or corporations engaging in retail business in the City of Montgomery, Alabama, or within the police jurisdiction thereof; Providing for the collection thereof: and providing penalties for the violation of this ordinance."

We further request that the passage of such ordinance be reconsidered and, if the same is not entirely repealed, that said ordinance be submitted to the vote of the electors of the City, either at a general election or at a special municipal election to be called for that purpose; and, that such ordinance shall not go into effect or become operative unless a majority of the qualified electors voting on the same shall vote in favor thereof.
