BUYER'S RIGHT TO CANCEL

If this agreement was solicited at your residence and you do not want the goods or services, you may cancel this agreement by delivering or mailing a notice to the seller. The notice must say that you do not want the goods or services and must be delivered or mailed before midnight of the third business day after you sign this agreement. Seller sells and Buyer(s) purchase(s) the above described services and property and Buyer(s) agree(s) to pay Seller the Total of Payments in consecutive monthly payments commencing on the First Payment Due Date. Buyer(s) agree(s) to the terms on the reverse side and grant(s) a purchase money security interest in the above described property to the Seller and assigns to secure payment of this contract. In event of default of ten (10) days or more in the making of any scheduled payment, Buyer agree(s) to pay a default charge not exceeding five (5%) per cent of the amount of such scheduled payment in default or fifty cents (50¢) whichever is greater.

If the Amount Financed exceeds \$300, Buyers agree to pay a reasonable attorney's fee if this contract is referred to an attorney, who is not a salaried employee of the holder hereof for collection. Such fee shall not exceed fifteen (15%) per cent of the unpaid debt after default.

Buyer(s) may prepay the contract in full at any time and shall receive a rebate of the unearned Finance Charge computed to the nearest scheduled due date using the Sum of the Digits Method. No refund of less than \$1.00 shall be made. If the contract is renewed or refinanced, within ninety (90) days from the date the contract is made such rebate of the unearned Finance Charge shall be computed on a daily pro rata basis from the date of such refinancing or renewal.
