By "destroy" as related to bottles, is meant breaking, crushing, or smashing, beyond possible re-use.

By "destroying" as related to the remaining contents of any partially empty bottle or bottle on which the Federal strip stamp has been broken, is meant pouring out such contents beyond the point of possible re-use or recapture, either through a sewer system or other disposal system.

By "as soon as reasonably possible" as above used, is meant immediately upon use, serving, or consuming the contents thereof, or as often or frequent thereafter as a lull in business will permit, but in any event not less than once each day.

Any ABC licensee, irrespective of the type license held, who fails to comply fully with the requirements of this rule and regulation, or on whose licensed premises or close enough thereto as to reasonably indicate use of such bottle or bottles on the licensed premises, are found any alcoholic beverage bottles, which under the requirements of this rule and regulation are required to be destroyed, will subject his or its license to possible immediate suspension or revocation.

RULE AND REGULATION PROMULGATED THIS  
17TH DAY OF AUGUST, 1960, BY THE ALABAMA  
ALCOHOLIC BEVERAGE CONTROL BOARD,  
MONTGOMERY, ALABAMA.

All clubs, now or hereafter, holding ABC club liquor licenses must furnish to the ABC Board at its office in Montgomery, Alabama, prior to the first day of October 1960, and each year thereafter prior to the first day of each succeeding July, a duly certified, true, correct, and complete list of all officers of such club, with their correct individual home mailing addresses, as well as a duly certified, true, correct, and complete list of all members of such club with their individual personal home mailing addresses.

In addition, all such clubs must furnish to the ABC Board, within fifteen days after any, each and every change in officers or of any officer, a duly certified certificate, indicating such change or changes, with the correct name and correct individual personal home mailing addresses of such new officer or officers.

In addition, all such clubs must furnish to the ABC Board, by the fifteenth day of each month, a duly certified, true and correct list showing the names of all persons who ceased to be members of the club during the preceding month, as well as a duly certified, true and correct list showing the names of all new members who became members of the club during the preceding month along with their correct individual personal home mailing addresses.

**RULE AND REGULATION PROMULGATED THIS  
17TH DAY OF AUGUST, 1960, BY THE ALABAMA  
ALCOHOLIC BEVERAGE CONTROL BOARD,  
MONTGOMERY, ALABAMA.**

In addition, all such clubs must furnish to the ABC Board, by the fifteenth day of each month, a duly certified, true, and correct statement listing the names, correct individual personal home mailing addresses of each and every person employed by such club, during the preceding month, along with a statement of the gross amount of salary, wages, commissions, and other remuneration, received by each said individual person during the month from the operation of said club.

All the various foregoing certified reports and lists required, are to be signed by the president and secretary of such club, and are to be duly acknowledged and certified both by such president and secretary as being true, correct, and complete, and such acknowledgments and certifications are to be duly made under oath before a notary public or other officer authorized by law to administer oaths, which said notary or other officer taking said acknowledgment, must certify same.

Failure of any club to comply with any of the above requirements, will result in appropriate disciplinary action by the Board, including failure of the Board to renew the license, or suspension or revocation of such license.

No alcoholic beverages may be kept, maintained or contained on any licensed premises, at any time, irrespective of for how short a period of time, in any container, bottle or receptacle, other than the bottle of manufacture and which bears an unbroken Federal strip stamp. Any alcoholic beverages found on the licensed premises other than in the original bottle of manufacture with unbroken Federal strip stamp shall be contraband and shall be grounds for disciplinary action against the licensee.

This shall obviously not apply to such beverages duly purchased by patrons and which such beverages are on the tables of such patrons pursuant to the lawful purchase and consumption of same.

All ABC liquor licensees are required to destroy as soon as reasonably possible, all empty or partially empty alcoholic beverages bottles, and all beverage bottles on which the Federal strip stamps have been broken, as well as destroy any remaining contents of any partially empty bottles, which have accumulated from use or any other source or purpose, on the licensed premises.
