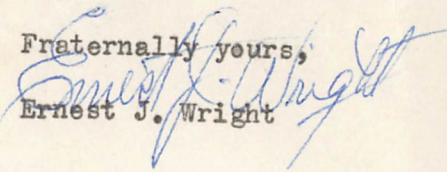


Dear Bro. Lewis:
