Dear Rufus:

We enclose herewith check for \$1,820.60 due you from your loan from The First National Bank for the purchase of 102.5 acres near Mt. Meigs. The total price for all property in which you were interested from the Lucas sale, including the Ross-Clayton property, was \$44,915.50. From this I have deducted \$17,753.00 for payment by a Ross-Clayton Funeral Home, Inc. check dated December 20, 1967, and I have deducted \$8,983.10, which you have already paid to the Register in Chancery. The balance due on your purchases to the Register is, therefore, \$18,179.40. We received from the bank on your behalf \$20,000.00, secured by your mortgage. The \$20,000.00 has been disbursed by check of \$18,179.40 to the Register in Chancery in final payment of your land purchase and our enclosed check for \$1,820.60 to you. Unless I hear from you prior to January 1, 1967, you will be billed on or after January 1st for your attorney's fee, recording and other expenses of closing the sale and loan.
